Consumers MAY Not submit this form directly. Only a propane marketer may apply for this rebate. To apply you must:

- (1) Type or print all required information; (2) Obtain customer signature; (3) Attach required documentation, copy of paid invoice showing purchase & installation of the qualifying water heater and the safety inspection record performed after the installation of the new qualifying water heater; (4) Double check for completeness and accuracy. (Errors may delay or disqualify this application.) (5) Rebate checks must be cashed within 90 days of the origination date; (6) Rebate checks are issued to Propane Marketer only; (7) Must be a residential installation in Iowa.
